Terms and conditions

The photographer(s) shall mean Philip Boak and/or any photographer appointed by him. The client(s) shall be those who names appear on this contract:
Photograph/Image/Digital Image shall for the purposes of this contract refer to those images taken by the photographer(s) and reproduced on cd/dvd/print whether digitally altered or not.

Copyright:

The copyright of the images remains with the photographer(s). However the photographer(s) do not grant ownership of title to the client but instead grant a conditional restricted license for use of the images, hereby termed an assignment.

Assignment:

The client is permitted to use the images provided on cd/dvd for their own use for a period of 15years. The client may not sell, trade, distribute, sub-license or transfer the license to another party. The client may not subject the images to derogatory treatment and the photographer(s) retain the right to be identified as the authors of the images.

Moral rights:

The client hereby allows the photographer(s) to display any photograph/image covered by this contract for advertising, brochures, magazine article, competition, websites and other such material, providing the images are used lawfully and without damage to the client(s). The photographer(s) will not be liable for images copied from the web by unscrupulous persons.

Creativity:

The photographer(s) will use their skill and ability in relation to the choice of poses and locations used. They will try to adhere to the wishes of the client(s) but cannot be held responsible for lack of images due to client, bride, groom or other members of the party not being available, willing or ready on time. Please be aware that officials from churches, registry office and marriage venues may place restrictions on the photographer(s) and may not in some circumstances allow any photographs to be taken. Likewise other venues may have restrictions or not allow photographs to be taken.

The photographer(s) will do their best to honour any requested photographs, but do not undertake to guarantee any specific picture, background, group or location. Likewise weather can also be a factor in the photographs taken.

Force Majeure:

In the unlikely event of total photographic failure, injury or sickness beyond the photographer(s) control, liability shall be limited to a full refund of monies paid. The photographer(s) will do their best to contact other photographers in the event of illness etc.

Colour Matching:

There are many variables in the processing of digital image files (and film also for that matter). This processing starts within the camera where it compresses even raw files, this continues within software on a computer and with the printing or reproduction on a computer monitor or tv set. Thus the photographer(s) cannot guarantee that the images will appear to be colour correct as the eye saw it on the day. They will endeavour to produce the best colour match possible.

Booking Fee:

A non-refundable booking fee of 25% of the total of the package is required at the time of booking, together with this signed contract, unless agreed otherwise. When the booking fee is paid the date will be reserved.

Balance Payment:

This should be made not less than 14 days prior to the wedding ceremony or event.

Cancellation:

In the event of the client(s) cancelling the wedding/event:

Within 1 month – 100%

Prior to 1 month – 25%

In the unlike event of the photographer(s) cancelling the contract (illness etc) their liability shall be limited to a full refund of any monies paid.

Insurance:

The client(s) are hereby advised to take out an insurance policy to cover any expenses in the event of cancellation.
